Broadband - The continued progress of the connecting Devon and Somerset scheme is being assessed by the Government.

A voucher scheme is in operation for the more rural areas that have difficulty with access to broadband.

There is now availability to purchase satellite equipment.

Abbots Way – Lighting – The issues are ongoing

Signage - Winsford Hill – After recent incidences involving Exmoor Ponies and motorists, Kate Brown (Som Council Highways) has agreed to meet with Cllr Rawle and the owners of the Anchor Herd of Exmoor ponies on site at Winsford Hill to locate the accident hot spots and advise on the best way forward with appropriate signage.

E.N.P.A - Car Parking, Haddon Hill - Concerns have been raised with regards the proposed changes because it could possibly lead to the public parking nearby on the roadside causing obstruction to other road users.

Music Park/Highercombe- - it was reported that some motorists are driving too fast. Members were informed that a request for signage, "Slow Down - Horses" is normally erected by the Police.

Local Community Network – The highways pilot scheme is already underway and proving successful. Certain issues will be prioritised, which may include affordable housing, education, transport, and social care.

South West and Taunton - Members were informed that a donation of ± 40.000 was given to Taunton Council with regards the celebrations concerning the coronation of King Charles when the Unitary Council was formed.
