#### **Questions for County and District Councillors:**

Cllr. Mr Nick Thwaites - S.W.T:

<u>S.W.T. Scrutiny Meeting:</u> Cllr. Mr Thwaites reported the following from the meeting: 1) That a suggestion was made that the parishes increase their precepts by 10% to cover anticipated costs. This proposal was robustly rejected.

2) A proposal has been submitted to consider producing a Local Plan to cover all of the District Councils and the E.N.P.A.

3) The regime is likely to change in the near future.

<u>SWT Shoppers Car Park Permits</u>: Following receipt of the response from SWT members agreed that the situation should be closely monitored and efforts continue ensure the continued use of cardboard clocks.

<u>B396 The Black Cat Junction - Potholes:</u> Members reported that the depth and number of potholes particularly in this location are seriously damaging vehicles. The problem has been reported to Devon County Council, however members of the public are urged to continue reporting the issue until it is resolved.

<u>Exmoor Panel Meeting – 12<sup>th</sup> January 2022:</u> Cllr. Mr Nick Thwaites agreed to attend the meeting. Details concerning the future salting of 'green routes' will be available.

<u>New Somerset Council:</u> Members were informed that the appointment of staff at the 'tier two' level is virtually complete, however at the senior level, where there exists structural change, positions are still to be filled.

<u>LCN Project:</u> It is not anticipated that the final arrangements will be functioning by  $1^{st}$  April 2023 as hoped. However, the budget has been approved enabling the pilot to continue for a further year.

The new Highways Steward has been appointed and commencing work today, 9<sup>th</sup> January 2023.
